In December 1974 Darlynn was sworn in and became the only female attorney among 130 New Jersey licensed attorneys practicing in Cumberland County at that time. Darlynn began her career at the Tuso & Gruccio office. She and Joseph Testa later formed the law partnership of Testa & Mann. After Joe ascended to the bench, Darlynn entered into a law partnership with Jay R. Moore, which eventually evolved into Mann, Moore, & Cavagnaro. Darlynn was a big sports fan who followed the Phillies, the Eagles, and Georgetown basketball. She also followed major golf tournaments. Darlynn set very high standards for the legions of female attorneys who have followed. Her reputation for the skillful handling of litigation, particularly matrimonial cases, was widely recognized throughout South Jersey. Darlynn passed away on January 24, 2006 at the age of 56.
